WHAT IS AN OPERATING ENGINEER?

These are the people who operate Heavy Equipment generally found on construction sites. Heavy Equipment consists of Cranes, Draglines, Clamshells, Hoists, Pile Drivers, Graders, Dozers, Loaders, Backhoes, Excavators, Earthmovers, Tractors, Scrapers, Rollers, Asphalt and Concrete and Pavers to name a few pieces of equipment as examples.



THE PROGRAM

International Union of Operating Engineers, Local 926 foresaw the need of training to generate skilled tradesmen; therefore, in 1969 we built and began operation of the Joint Apprenticeship & Skill Upgrade Program. The Joint Apprentice Committee offers a comprehensive Training Program. Operating Engineers receive 8,000 hours of on-the-job training (earn while you learn). Apprentices will be required to attend school (classroom and related training) in subjects related to the trade for at least 196 hours per year, for each year of their Apprenticeship. The Apprentice will receive two (2) weeks of related instructions when first indentured and one (1) week each quarter thereafter at the Field Training Site. The Apprentice will not receive any pay for related instruction or classroom instruction.

QUALIFICATIONS

The basic requirements and qualifications for admittance into the program are as follows:

AGE:

APPRENTICE APPLICANTS MUST BE AT LEAST EIGHTEEN (18) YEARS OF AGE. (MUST PROVIDE A CERTIFIED BIRTH CERTIFICATE).

EDUCATION:

APPLICANTS MUST PROVIDE A HIGH SCHOOL DIPLOMA OR G.E.D. CERTIFICATE.

TRANSPORTATION:

APPLICANTS MUST PROVIDE PROOF OF A VALID DRIVER'S LICENSE AND MUST BE ABLE TO TRAVEL OUTSIDE OF METRO-ATLANTA.

MUST BE DRUG FREE:

APPLICANTS MUST BE WILLING TO TAKE PRE-EMPLOYMENT DRUG TEST.

REFERENCE LETTER:

PERSONAL CHARACTER REFERENCE LETTER IS ACCEPTABLE, HOWEVER, ANY REFERENCE LETTER FROM AN EMPLOYER, SCHOOL, BUSINESS, CHURCH OR WORK EXPERIENCE RELATED TO THE THIS TRADE OR THE CONSTRUCTION BUSINESS MUST BE ON LETTERHEAD STATIONERY.

PROVIDE A 3 YEAR MOTOR VEHICLE DRIVING RECORD

Selection of students is made from applications and personal interview scores, applicants are indentured numerically, starting with the highest scoring applicant until all available openings have been filled.

Qualifications are subject to change, upon approval of US DOL Bureau of Apprenticeship & Training

TrainingApprentice wages are based on a percentage of the Journeyman rates:
